KEY TERMS & CONDITIONS

Once payment has been submitted you will be redirected to instructions for setting up a getting to know you session. During this session we will discuss your objectives and set times for your sessions.

SESSIONS

Sessions will be conducted online using Zoom. Subject to your consent recordings will be made of our sessions and made available for you to refer back to. Recordings will be added to a private Slack channel for you to access and download. Your channel will be available for at least 4 weeks after your session.

There will be 2 x 60 minute sessions plus one 30 minute follow up session 2 to 4 weeks after your final session.

You will have a private Slack channel available to ask any questions arising from your sessions and request feedback on implementation of the work we cover in the sessions.

PAYMENT OPTIONS

Soul Expression Immersions are available for £555 pay in full or £ 576 for instalments. Immersions can be reserved by making a payment of £88 through Paypal. The reservation fee is deducted from the full fee.

If you are paying in full, the balance of £467 will be requested via invoice and can be made via card or bank transfer. Payment in full must be received prior to the start of your programme.

If you wish to pay via instalments, the balance of £488 will be requested over 2 monthly payments of £244 via invoice. Payment can be made via card or bank transfer. The initial instalment must be received prior to the start of your programme.

CANCELLATION & REFUNDS

Reservation fees are not refundable.

Should I need to cancel our agreement I will explain this to you and provide a full refund of all fees paid.

You can cancel the agreement within 14 days and receive a full refund *provided that your programme has not already begun*. If your session is held within 14 days, refunds will be purely discretionary.

Please note that any digital content supplied cannot be refunded once it has been accessed.

RESCHEDULING SESSIONS

Should I need to reschedule a session I will do my best to provide you with at least 24 hours' notice. Should you need to reschedule a session, you also agree to provide 24 hours' notice.
